



MEMBERSHIP RULES

Pleasures Retreat Adult Social Club (the “Club”) is a private unincorporated association established to provide opportunities for couples interested in the ‘swinging’ and ‘alternative lifestyle’ scene to meet others with similar interests in a social setting without any pressure or obligations. It is a private membership club, whose members understand and agree to the following:

1. The purpose of the Club is to provide education about human sexuality as well as to provide functions and events at which all manner of human sexuality may be explored and on display.
2. Members of the Club, by signing this application form, confirm that they are:
 - a. 19 years of age or older;
 - b. aware that they may observe nudity, sexual acts, including, but not limited to, intercourse, BDSM play, and other assorted activities that non-members may find offensive or objectionable while attending functions and events held by the Club;
 - c. accepting that such activities listed in point b) may be observed, and that they do not find such activities offensive, objectionable, or against their personally held standards;
 - d. aware that ‘swinging’ and ‘alternative lifestyle activities’ (as they are commonly known) may take place at functions and events held by the Club, and that, by being present, they confirm that they are not personally offended by such activities.
3. The Club may hold both on-premise and off-premise functions and events and depending on the nature of the event, certain rules may be in place limiting or restricting the type of conduct in which Members can participate. In all cases, illegal conduct is strictly prohibited; however, if any additional conduct is prohibited for a particular event, these prohibitions will be listed at the entrance to the function or event.
4. If Club events are held at licensed premises, then the rules of that licensed premise regarding alcohol shall apply. If Club events are held at premises without a liquor license, then the Member may bring alcohol for their own consumption. In such cases, the Club, or its designate, shall provide a bartender to dispense the Member’s alcohol.
5. In order to ensure the Club’s events remain legal, the Club shall enforce a strict drug prohibition. No illegal drugs of any kind shall be permitted at Club Events. A breach of this clause shall be grounds for immediate expulsion from the event, and from membership in the Club.
6. All activities at Club events are consensual activities between informed, consenting adults. As such, any non-consensual contact is unacceptable and shall be grounds for expulsion from the event and from membership in the Club.

7. Pursuant to the *Personal Information Protection Act* and the *Privacy Act* all personal information about Members of the Club is considered private and not to be distributed or disseminated except as required by law. As such, Members are prohibited from taking any photographic or audio recordings at any Club events. Anyone found violating this rule will face expulsion from the event, expulsion from the Club, and possible legal action.
8. I warrant that I am not a member or affiliate of the press seeking to publish information on the Club in any media whatsoever without the express permission of the Club. I further warrant that I am not a member or affiliate of any law enforcement or regulatory association seeking to investigate the club or its members. If I am a member or affiliate of the press, or any law enforcement or regulatory agency, I shall disclose this fact upon seeking membership. The Club shall then decide whether to grant membership in the Club.
9. I am interested in actively and personally exploring this lifestyle for personal enrichment. I am not obligated to enter into a swinging relationship with anyone at this point or in the future.
10. Breach of any of the above membership conditions is cause for membership to be revoked. There is no right of appeal against a decision to revoke membership.
11. Memberships are non refundable for any reason.
12. The Club reserves the right to refuse admission and membership to anyone without cause or explanation.
13. All members attending the Club are required to be courteous, law abiding and friendly at all times. We reserve the right to demand anyone to leave and/or revoke membership of any person who becomes obnoxious, unruly, engages in any illegal acts.
14. I have read and understood the Club rules and agree to abide by them. I also understand that the purpose of the Club is for people interested in the 'swinging' or 'alternative lifestyle' scene, to get together with other like-minded couples for socializing, dancing and uninhibited conversation and activities. I also understand that full or partial nudity and sexual situations can occur and that I am not offended by this.
