



**PLEASURES RETREAT ADULT SOCIAL CLUB (the “Club”)
PRIVACY AGREEMENT**

All Members must agree to this Privacy Agreement before being allowed to attend any events sponsored by the Club.

1. Representation of Good Faith

I represent that I have approached the Club seeking membership in a sincere desire to experience and possibly participate in the lifestyle of its' members, intending no harm, interference or disruption to the organization or to the lives of any who adhere to its precepts. In consideration of being permitted to attend an event sponsored by Club, I agree as follows.

2. Protection of privacy

I recognize that the philosophy of the Club is controversial to some, and that activities conducted in pursuance of it are also, and I will respect the privacy of the Club and its members, including but not limited to the following:

(a) I will not divulge the identity of anyone as a member of the Club to anyone outside of the Club without their permission;

(b) I will not discuss or disclose any of my experiences in the Club with anyone outside the Club, without the permission of the Club, except that I may discuss my experiences in a way which does not permit the Club or its Members to be identified;

(c) I will not disclose the location of any place where we have attended any activities of the Club without the consent of the Club. I am not offended by nudity or sexual interaction in my presence in private settings.

(d) I will not bring any device that can record images or sounds to any Club event. This includes, but is not limited to, cameras, camera phones and tape recorders. Should I inadvertently bring such a device to a Club event, I shall leave it with a Club host or hostess for retrieval upon leaving the Club event. I shall not make any recording, either photographic or sound, at any Club event without the express written consent of the Club or its authorized agents. If I do make such recordings, I understand that I am breaching the statutory and common law privacy rights of other Members and that I will be liable at law for such breaches.

3. Indemnity

I agree to indemnify and hold harmless the Club for any harm resulting from any violation of this agreement.

4. Notice of compelled or requested testimony

I agree to notify the Club immediately upon receiving information that I will be required or

requested to give evidence to any public official or court in any matter relating to the Club. I agree to assert all available privileges and not to give such evidence unless compelled by a court. (Remember, you can politely say NO to a police officer requesting a statement. It's your right.)

5. Provision as to police officers and other agents

The Club understands that police have a duty to enforce laws and to investigate suspected violations of them, but that provincial and federal laws limit the rights of police and government agencies to do certain things without consent. I warrant that, if I am a police officer or government agent of any kind, I am present at any Club event only in my private, individual capacity. I warrant that, if the foregoing statement should prove to be false, I am investigating the Club or its Members without disclosing my official capacity or purpose, and that my presence at any Club-controlled premises, or those of its affiliates or Members, is an entry into private premises without consent;

6. Provision as to members of the press

I represent that, if I am a member of the press (including television or radio), I am present at any Club event only in my private, individual capacity. I warrant that, if the foregoing statement proves to be false, and I am here at the direction of my employer and am acting within the scope of my employment; that I am violating the rights of the Club and its Members to privacy, under common law and the laws of the British Columbia.

7. Privacy of Members' information

All information provided by Members or prospective members to the Club will be held in the strictest confidence by the Club and shall only be shared with Pleasures Retreat Ltd., which shall also be bound to maintain the same confidentiality. The Club shall abide by the *Personal Information Protection Act* and the *Privacy Act* and shall not provide a Member or prospective member's personal information to anyone, except when required by court order. The Member's personal information, once gathered, shall be held offsite from the premises in which the Club is holding an event and only the Member's first name and membership number will be held at a Club event. All other personal information, including copies of government issued identification, shall be held at the offices of the Club's solicitors.
